- b. Feedback from alumni working in industries on curriculum.

The link for the feedback is available on the institute's website. The feedback gives valuable inputs in designing the curricula which suit requirements of the industry.

3. The curriculum of M.A. in Psychology has two specializations at Part II level: a. Clinical Psychology b. Child and Adolescent Psychology. The curriculum is designed with focus on employability. The students can work as counselors in different areas.
4. In all 49 different Skill Based Courses are conducted in the college of which 29 courses are outsourced to professional organizations. Formal MoUs are signed with all of them.
5. Question papers of all the classes are audited by the Board of Studies in respective subjects. The system of question paper setting is as below:
  - A. The Board of Examination has prepared an Examination Manual in which all the guidelines related to question paper setting are clearly stated.
  - B. The head of the department scrutinizes the question paper sets before submission.
  - C. The head is required to sign an undertaking stating the fulfillment of all the guidelines.
6. Caution money will be included in the fee structure of the B. Voc. course from next academic year.
7. M. A. in English and M.Sc. in Data Science programmes will be started from next academic year i.e. 2020-21.
8. Academic audit with external members in the Peer Team will be conducted as soon as the college reopens and suggestions will be discussed with the faculty members as a part of quality enhancement.



9. Students are given constant motivation for innovation. All the schemes of our parent institute regarding research like, Project based learning, Model based learning, Idea bank are implemented for the benefit of the students. As suggested by Hon. Dr. Anil Patil, the innovative ideas of students are taken forward by applying for patents. Department of Chemistry has filed 8 patents under the guidance of Principal Shivankar. 10. Innovation grants and research grants are constituted in the college for the students and will be operational from the next academic year. Currently funding is allotted to cover the expenses of students who participate in various research conventions and conferences for research paper presentation.
11. A special attention is given to behavior of non-teaching staff with students. They are guided time to time on soft skills. The complaints are reduced drastically. A Soft skill workshop in Marathi will be arranged for them as soon as college opens. There are no issues of sanitation and cleanliness as the entire work is outsourced and it is monitored by Cleanliness Committee.
