She firstly focused on the CBCS system that was to be implemented from the academic year 2022-23. In this, all the undergraduate programs offered by grantable departments will have 132 credits and all the self-financed programs will have 148 credits. All the post-graduate programs will be having 112 credits. She elaborated on different courses offered in CBCS, such as core courses, ability enhancement courses, discipline specific elective courses, generic electives and skill enhancement courses. An individual research project is an integral part of all P.G. courses under CBCS. Prof. Shubhada Nayak also explained the importance of outcome-based education and how it is followed in the institution. The status of research (Research publications, patents and books published by faculty members) was also highlighted in the meeting. She mentioned the courses conducted by the Training and Placement Cell on employability and skilling in collaboration with American India Foundation. She also elaborated on activities conducted by Mahindra Pride Classrooms i.e. six days training program on soft employability skills. She gave information about the JOB fare organized by the Placement cell. She presented the main activities of National Social Services (NSS) & National Cadet Corps (NCC). Achievements of our students in various sports at different levels were also highlighted. She also focused on seminars, webinars, conferences, workshops, fests and training programs organized by various departments for the students & teachers. A proud moment for college was the Cleanliness Award by NMMC.
