followed by the agenda reading.

#### Reading of Agenda:

Motion from Mr.C.D.Bhosale: To approve the agenda for 20th April 2021. Vote All infavor.

Resolved: Motion carried.

Agenda for the meeting on 20th April 2021 was approved without modification.

#### **Business:**

Motion 1[from Mr.C.D.Bhosale]: Significant matters since last year 2020-21 IQAC meeting

Discussion: Mr.C.D.Bhosale informed about the activities conducted by college in the first term of the academic year 2020-21. He explained how the college teachers are conducting on line teaching, learning and evaluation activities. He informed about the digital platforms which the college is using for the academic activities. He presented the data of teacher's research publication and patents registration. He informed about the coursera for campus status received by our college which is beneficial to students to join online certificate courses available from reputed international universities at free of cost. He presented the activities conducted by IQAC and college in the first term. All members appreciated the work done by college during lockdown period.

Motion 2: Starting of singing and music certificate courses. [Criterion 1]

Description: In the last NAAC pear team visit, considering more percentage of girl students of the institute, members of peer team recommended to start course on performing art, music and dance.

Discussion: Mr.C.D.Bhosale informed the committee members that college applied to University of Mumbai for permission to start the course, but University is not giving permission to institutes as they have their separate department. So we decided to start certificate course by inviting proposals from outside professionals. We received proposal from Mr. Anurag Naik who is a Sangit Visharad and professional singer and student can take it for giving the exam of Gandharva Vishwa vidyalaya. There will small batches and will be evening classes for vocal and instrumental music.

Motion 3: Application for permission to start NCC unit[Criterion I]

Description: There is one more suggestion from Peer members to start independent NCC unit. Institute is trying from last 10 years to establish separate unit and also applied for that to the Commanding Officer NCC Office, Mumbai. As every state has some quota for financial grant and number of units, applicants for NCC unit are on waiting list. Commanding Officer NCC Office is granting permission to start Unit on self-finance basis. Committee decided to go for starting NCC unit on self-finance basis.

Discussion: committee suggested to collect the information of expenditure to be incurred for NCC unit from nearly college NCC units and decided to submit fresh application for self-finance NCC Unit

Motion 4: Teachers' training on online teaching & e-content development | Criterion

Discussion: As teaching, learning and assessment activities are online. Mr.C.D.Bhosale informed about the need for teachers training on on line teaching and e-content development. Dr.Rita Mukhopadyaya suggested Coursera online certificate course for teachers. It was decided to arrange teachers training programme on line teaching and e-content development.

Discussion: .Shubhada Nayak informed the members about the CIII Kharghar center and as Mumbai and Navi Mumbai is an expensive city people startup infrastructure cost is so high coworking space but we do not have labs there, therefore she need of finance Dr.Lalitha Dhareshwar and Dr.Rita Mukhopadhaya informed about the CIBA and Father Agnel incubation centers and assured to provide information about formation of center of excellence in Bio Tech.Manoj Jalanawal suggested to collect the information of State and Central Govt. schemes for start-up purpose accordingly we can gear up the activities of CIII. Ms.Saloni suggested starting the approach to the students' right from the first year students by establishing separate cell .Small projects can be given to them where thinking can starts towards entrepreneurship.
